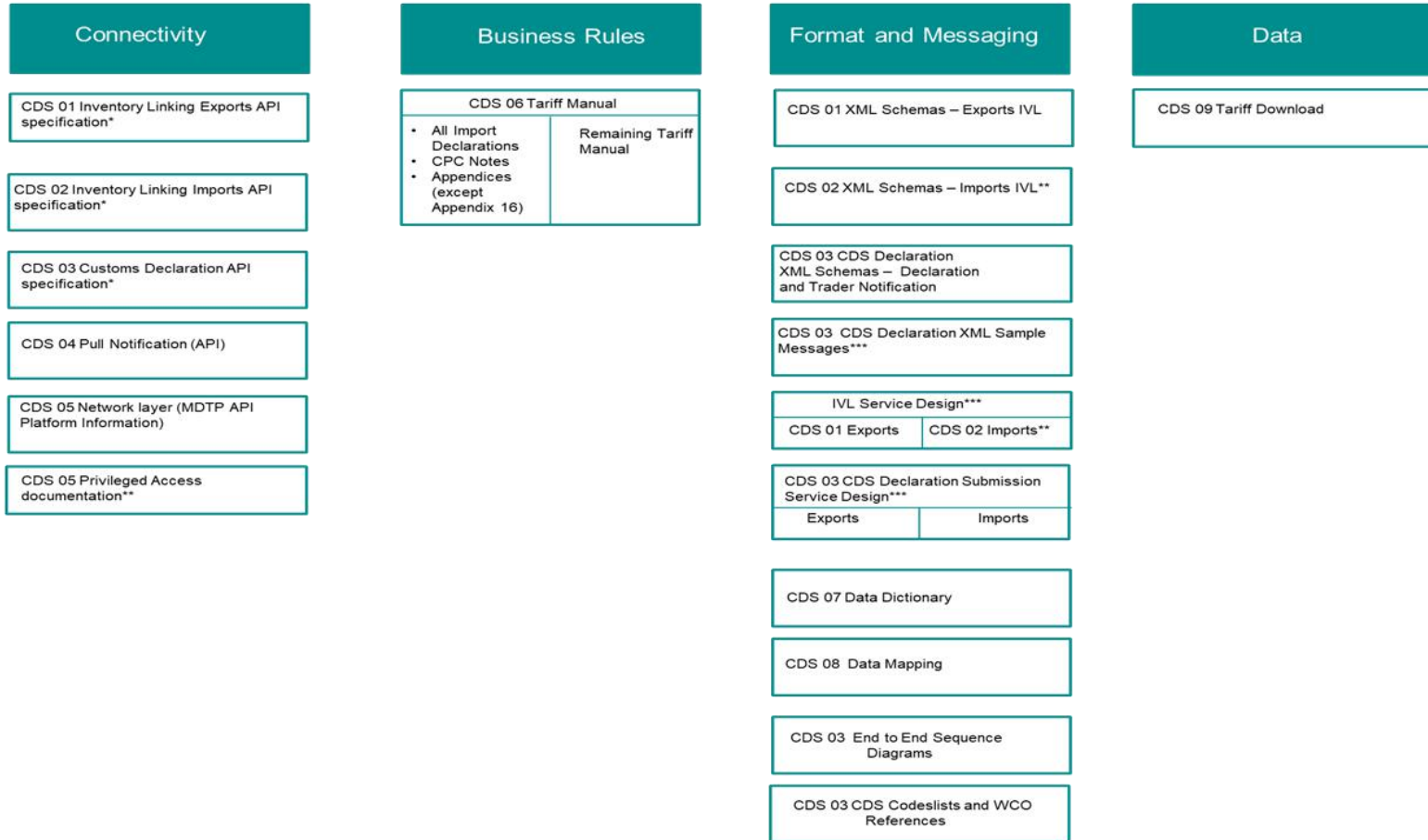

Purpose of the document

- The purpose of this document is to provide a revised and consolidated list of all the technical documentation issued to software houses and CSPs.
- The documentation has been rationalised into 4 main sections: connectivity, rules, format and messaging and data.
- The full document set is uploaded onto the Google Drive within the new folders listed in this document. The previous versions of all the documentation are saved in the Archive folder. The files uploaded within the new folders will be the latest versions of the documents and no references to the previous versions will be required.
- Documents that will be iterated for further Trade Test drops will be issued together with the updated version of this document set list to allow for easier tracking of all the changes.
- Based on your feedback we are issuing the below listed new CDS Functional Specification documentation:
 - Inventory Linking Imports Service Design – latest version issued on 10/05
 - Inventory Linking Exports Service Design – TBC
 - CDS Declaration Submission Service Design Imports - 24/04
 - CDS Declaration Submission Service Design Exports – TBC
 - CDS End to End Sequence Diagrams – latest version issued on 24/04
 - CDS Codelists and WCO References – latest version issued 17/04
- The new End to End Sequence Diagrams document (new Doc Ref CDS 10) replace the old Message Interaction Sequence Diagrams document (old Doc Ref 4)
- The CDS Codelists and WCO References document defines the WCO tags used within CDS pointers as well as any technical codelists that are not referenced within the Paper Tariff. This document has been created mid-way through an agile process and is therefore subject to change.
